- F) Maciejewski Property Kerry will make Larry and Howard a copy of the information we have on the property so they can walk the property.
- G) Informational Handouts Kerry is having the Assessor verify the addresses on the list of parcels for the next meeting so the board can move forward with sending out letters to residents. Kim gave Kerry a copy of the presentation to review, the board will review at the August meeting.
