- D) Love Property Ray received the savings numbers from Kerry and the savings are roughly 4%. The next step is to contact Elizabeth Love and let her know the numbers and see how she would like to proceed.
- E) Jones Property Kim is also going to write up a statement regarding the wetlands and flood plains on the property to attach to the BDR. Once the statement is complete we can resubmit the property to the Town Board at a work session.
- F) Rupp Property Bill Jackson went out and took pictures and is in the process of writing up the BDR on the property. The information will be sent to the Rupp's and to Kerry to forward to the remainder of the conservation board.
