The meeting opened with the reciting of the Pledge of Allegiance.

Making the legal notice for the Public Hearing on Local Law #1-2019 Flood Damage Prevention in the Town of Elma and will replace Town Code Chapter 82 part of the minutes, Deputy Supervisor Malczewski opened the public hearing at 7:00PM. Building Inspector Joe Colern stated the Local Law is an update and replacement to current Local Law Section 82 of the Town Code regarding Flood Plain Management Law. If someone wants to build/reconstruct in flood plain area the Local Law coordinates with FEMA Law & the DEC Law. The DEC came out with new maps which will be effective June 7th, 2019 showing new flood plain overlays in the Town. The new Law will coordinate with new maps which is what the DEC and Federal Government are requiring. No one spoke for or against. Deputy Supervisor Malczewski closed the Public Hearing at 7:04PM.

Department Reports:

Town Engineer James Wyzykiewicz reported on the Highland Drive Drainage District. Phase I is complete and suggests the Town proceed further with Phase II and have bid documents created for construction drawings for Phase II for the Drainage District. He recommends the Town proceed with Wm Schutt & Associates to draw up bid documents for construction drawings at the cost of \$4500.00. The residents have been informed of the costs of this project. (Mr. Wyzykiewicz had to leave the meeting after his report).

Councilman Petrocy made the motion and Councilman Nolan seconded the motion to add an item to the agenda. Ayes -4. Noes -0. Carried.

Councilman Petrocy made the motion and Councilman Nolan seconded the motion to hire Wm Schutt & Associates as requested by residents for \$4500.00 to create the bid documents for Phase II of the Highland Drainage project. Ayes- 4. Noes - 0. Carried.

Building Inspector Joseph Colern presented the monthly report for March 2019 with 31 permits issued, fees collected of \$11,705.42 with an estimated value of construction at \$6,621,854.00.

Plant Manager Brian Fiden reported the Water Department has been working with the Highway Department on the new septic at the new Highway garage. The water was turned on for the construction work. Brian mentioned that two (2) existing pumps at the Transit Road pumping station and one (1) existing pump at the Jamison Road pumping station need upgrading and also the water tank on Transit Rd needs to be painted and refurbished. Brian submitted quotes for the work. The Water Department will be going to a four (4) day work week with employees alternating work days allowing the Water Department to still be open Monday thru Friday. After hour calls will be handled accordingly.

Highway Superintendent Wayne Clark stated the Town lost money in funding for winter recovery. He is looking into Pave New York program. The Transfer Station will be open normal hours on Friday, April 19th (Good Friday) and Saturday, April 20th. Brush pickup started. The bathrooms at the Village Green Park should be open in about a week depending on the temperature/weather.

Town Attorney Phyllis Todoro stated she is working with two (2) residents on Oaknoll regarding a drainage issue.

Deputy Town Attorney Dean Puleo noted the Board will need to go into Executive Session after the Board meeting to discuss a legal matter.
