## 03/07/07 Town Board Minutes

A regular meeting of the Elma Town Board was held on Wednesday, March 7, 2007, at 8:00 PM, Elma

Historical Museum, 3011 Bowen Road, Elma, New York, to celebrate the Town of ElmaÆs 150th year at the original meeting place of the Town of Elma forefathers with the following members present:

Supervisor Michael Nolan Councilwoman Susan Glownia Councilman David Polak Councilman Dennis Powers Councilman Dean Puleo

Approximately 60 people attended the meeting at the Historical Museum (C.W. Hurd house, site of the first Town of Elma meeting) with the over flow in the Senior Center.

The meeting was opened with the reciting of the Pledge of Allegiance.

Supervisor Nolan welcomed Honored Guests and all in attendance.

Supervisor Nolan read a brief excerpt from the ôHistory of Elma, 1620-1901 by Warren Jackman, ElmaÆs first Town Clerk.

Councilman Powers made the motion and Councilwoman Glownia seconded the motion to approve the February 21, 2007 minutes. Ayes-5. Noes-0. Carried.

Supervisor Nolan presented the new Sesquicentennial transfer station stickers that will be available in the Town ClerkÆs office.

Sheriff of Erie County Timothy B. Howard arriving on horse back with the formal delivery of Proclamations honoring the Sesquicentennial which are as follows:

Sheriff of Erie County Timothy B. Howard presented the following Citation Whereas, the Town of Elma is celebrating itÆs 150th year of its founding on March 7,

2007 at the Hurd house where the first Town meeting was held in 1857, and this meeting is to honor its founders and Elma's 150 years of progress; and Whereas, established in February 1821, the Erie County Sheriff has been embodied with protecting itÆs citizens, with Grover Cleveland as Erie County Sheriff in 1871 and later became President of the United States; and Whereas, through the 150 year history of this great community the Erie County Sheriff has had the honor of protecting the community and its residents; and Whereas, In celebration of the rich history, and the pride its residents have in their town, and the welcome the SheriffÆs department has received in this community, therefore, be it, Resolved, that as elected Sheriff of the County of Erie, in the State of New York, I, Timothy B. Howard do hereby cite the Community of Elma, during this historic Town event, and wish you a safe celebration during the, 150TH CELEBRATION OF THE TOWN OF ELMA

Councilman Powers presented the following County of Erie Proclamation Whereas, on Wednesday, March 7, 2007 the Town of Elma will celebrate the great milestone of their 150th Sesquicentennial Anniversary; and Whereas, an official Town Meeting will be held to formally start the celebration at the Hurd House in Elma, New York, which is the site of the first town meeting in 1857; and Whereas, the town of Elma was split from the Towns of Aurora and Lancaster, encompassing 36 square miles with two major waterways, the Buffalo Creek and Cazenovia Creek, Elma sits squarely in the center of Erie County and can safely call itself the ôHeartö of Erie County; and Whereas, over 11,304 residents call Elma home, as does Iroquois Central School, one of Western New YorkÆs top rated school systems, and Elma Meadows Golf Course, one of Erie CountyÆs top public courses, residents enjoy spending time with their family and friends at two of ElmaÆs parks, the Elma Village Green and Creek Road Park; and Whereas, the celebration of the 150th Anniversary of the Town of Elma is a wonderful achievement for all those hard working individuals who have helped make the Town a great success; Now, Therefore, I Joel A. Giambra, Erie County Executive, in honor of the celebration of the 150th Sesquicentennial Anniversary of the Town of Elma, do hereby declare, Wednesday, March 7, 2007 ôTOWN OF ELMA DAYö In this Majestic County of Erie, of the Great State of New York, The Empire State.

Councilman Polak presented the following Citation from Governor Spitzer Whereas, a celebration of pride and public acknowledgement of a communityÆs place in the history of the Empire State draws our citizens together to share a special moment-one which will preserve our rich heritage today and for generations to come; this occasion

Councilman Puleo presented the Congressional Record, House of Representatives remarks by the Honorable Brain Higgins

## Erie County Legislature Kathy Konst presented the following

Whereas, the Town of Elma situated a little northeast of the center of the county with Lancaster on the north, Marilla on the east, Aurora on the south, and West Seneca and East Hamburg on the west, and Whereas, Elma was the last town formed in Erie County, and Whereas, The Town of Elma was formed from parts of the towns of Aurora and Lancaster, and Whereas, Because of its location, Elma is referred to as the ôheart of Erie Countyö, and Whereas, On March 7, 1857, prominent officials from the area met at Mr. Clark HurdÆs house to organize the new town, and Whereas, at the first town meeting a resident suggested that the town be named after the famous American elm tree that was growing in the town on the corner of Clinton and Bowen roads, and Whereas, Paul B Lathrop was elected the first town supervisor at that meeting also, and Whereas, March 7, 2007 the Town of Elma is celebrating the townÆs sesquicentennial, and Whereas, It has been 150 years since the Town of Elma had its first meeting at Mr. HurdÆs house, and Whereas, Tonight ElmaÆs Town Board meeting will be the kick off of ElmaÆs Sesquicentennial year long celebration at the Elma Historical Museum which was the site if the first Town Board meeting, Now Therefore Be It Resolved, that Legislator Kathy Konst and the members of the Erie County Legislature do hereby pause in their deliberations to recognize the Town of Elma, and be it further Resolved, that this Honorable Body joins area communities throughout Erie County in celebrating the 150th Anniversary of the Town of Elma, ôthe Heart of Erie Countyö

Councilman Puleo made the motion and Councilman Powers seconded the motion to accept the following Proclamation: Whereas, On march 7, 1857 a group of men gathered in the home of Clark W. Hurd to establish a new Town within the County of Erie in the State of New York called ôElmaö Whereas, The Town of Elma was created from parts of Lancaster and Aurora encompassing 36 Square miles and bordered by the Town of Marilla to the East, Village of Lancaster to the North, Town of West Seneca to the West and Town of Aurora to the South and centered with the County of Erie, and, Whereas, Since that time, the Town of Elma has enjoyed a steady, regular growth but has maintained those qualities of place and people which make life rich and rewarding and, Whereas, the Town of Elma this year is celebrating its Sesquicentennial with numerous civic, cultural and recreational activities, including fireworks, parades, and family related activities; now, therefore, be it, Resolved, On this day of march 7, 2007 the Town Board of the Town of Elma does hereby extend its whole-hearted and sincere congratulations to the town of Elma. In Honor of our founding fathers and their struggle in creating the Town of Elma, we herby proclaim the year 2007 as: ELMAÆS SESQUICENTENNIAL YEAR and urges all its residents and friends to participate in and contribute to the commemorative activities and events of this memorable occasion.
