II BALDUCCI CONCRETE, 521 Pound Rd - ENLARGE PARKING LOT

Owner/Contractor Robert Balducci, as a follow up to 5/15/12 EPB meeting, was requesting Final Site Plan Approval to enlarge his parking lot. Mr. Balducci sent an email requesting withdrawl from the Agenda until the SWPP for the new drainage plan is completed - being requested by Town Engineer Wyzykiewicz.

III SEASONAL NURSERY. 1120 Bullis Rd, REVISED SITE PLANS

Owner Bryan Young of Young Development appeared before the EPB, requesting approval of revisions to the approved Site Plan made on 6/25/12. In particular he requested the chain link fence be eliminated, stating that "it looks too institutional and it is too close to the wetlands". On the other hand he will still install a gate. He also wishes not to install a 6' stockade fence in the back going along two neighbors' property.

Mr. Young said the berm has two hundred trees planted, 50% are evergreens, and is now the buffer between Seasonal Landscaping and the neighbors. In one area he said there are large trees on top of the ground which are for sale. When sold, they will be replaced with like stock. A small contingent of neighbors living in the adjacent area were allowed to respond to Mr. Young's request for changes. Mr. Young said "he was moving the topsoil building 33 feet from the line and moved another building 37feet". The EPB did not respond. Mr. Cirocco suggested that each EPB member visit the site before the October meeting to familiarize themselves with the issues and make a determination then. All members agreed.
