I. APPROVAL OF REGULAR MEETING MINUTES ~ APRIL 18, 2017

Minutes from April 18, 2017 meeting did not require any action to be taken due to applicant did not appear for the EPB meeting.

II. SEEKING SITE PLAN APPLICATION FOR NEW CLINTON STREET BUILDING LOT

Thomas Wagner of 8 Deercrest Court in Elma is seeking application to increase the size of a non-conforming lot which he owns on Clinton Street (Sublot 31). Mr. Wagner would like to take some property from his lot on 8 Deercrest and add as much as he needs to make his lot on Clinton Street a buildable lot. The EPB reviewed the plans that were submitted by Mr. Wagner and per Elma Town Code §100-3. Lots beyond the four-split rule; the following requirements will need to be met. A minimum lot area of two acres, with a minimum frontage of 150 feet, with a minimum depth of 350 feet and with a minimum of 25 feet side setbacks from the tile, leech field or other allowable systems, except a system to fill, to the property lines. Mr. Wagner must submit a new stamped survey to the building department along with an amended map cover of the Subdivision. The requirements have been met to change the two lots however the EPB cannot act tonight due to a contingency for providing the stamped survey showing new property sizes along with an amended map cover.

The EPB reviewed the SEQR and approved it with noted changes made. Chairman Cirocco made a motion to approve the SEQR and second Mr. Merkle. Motion carried.
