3) Quillin Property (6501 Clinton Street-46 acres) – Larry is reaching out to Mr. Quillin to see if he has the original survey, once we have that we can move forward to present to the Town Board.

4) Wilson Property (2860 Bowen Road-22.5 acres) – Kerry will send Ray an application that can be sent to Ms. Wilson.

5) Ducks Unlimited (2670 West Blood Road-28.98 acres) – Dave is going to stop by and introduce himself to the new owner, Jamie Carlone and see if she may be interested in an easement on the property.
