Department Reports:

Building Inspector Joseph Colern mentioned to the Town Board of the ceiling collapse due to a roof leak at PageÆs Paradise on Transit Road. The room affected by the ceiling collapse will be closed until all damage are assessed and repaired.

Water Superintendent Eugene Stevenson noted that the backflow program is complete at Steuben Foods.

Pump #1 (45 years old) at the Transit Road Shop is in need of repairs, the pump has been taken apart, and costs of the repairs are being evaluated. Also if residents could clean out the snow in front of fire hydrants on their property it would be greatly appreciated.

Councilman Puleo made the motion and Councilwoman Glownia seconded the motion to

issue a negative declaration on a short form SEQR for Daniel L Smolarek/Attorney and Scott R Smolarek/Dentist at 5121 Clinton Street. Ayes-3. Noes-0. Carried.
