A regular meeting of the Elma Town Board was held on Wednesday, April 19, 2006, at 8:00 PM, Elma Town Hall, 1600 Bowen Road, Elma, New York, with the following members present:

The meeting was opened with the reciting of the Pledge of Allegiance.

Making the Legal Notice for the Public Hearing on Drainage District #174/Kirkwood Drive for Mr. Trumpler part of the minutes. Deputy Supervisor Puleo opened the public hearing at 8:01PM. No one spoke for or against the Drainage District #174. Deputy Supervisor Puleo closed the public hearing at 8:02PM.

Councilman Powers made the motion and Councilwoman Glownia seconded the motion to approve Drainage District #174 on Kirkwood Drive for Mr. Trumpler. Ayes-4. Noes-0. Carried.

Making the Legal Notice for the Public Hearing on Drainage District #175/Seneca Street for Mr. Gough part of the minutes. Deputy Supervisor Puleo opened the public hearing at 8:02PM.

Building Inspector Joseph Colern would like to meet with Town Board members to discuss the correct action for the property at 900 Aurora Street due to a recent fire. Town Engineer James Wyzykiewicz noted that the beaver baffle will be installed the first week of May in the West Blood Road area.
