A regular meeting of the Elma Town Board was held on Wednesday, March 2, 2005, at 8:00 PM, Elma Town Hall, 1600 Bowen Road, Elma, New York, with the following members present:

Approximately 25 people attended the meeting.

The meeting was opened with the reciting of the Pledge of Allegiance.

Councilman Cirocco made the motion and Councilwoman Glownia seconded the motion to approve the minutes from the February 16, 2005 meeting. Ayes-5. Noes-0. Carried.

Department Reports

Building Inspector Joseph Colern presented his monthly reports for January and February with 18 permits issued, \$6,841.85 in fees collected with an estimated value of construction of \$1,350,140.

Water Superintendent Eugene Stevenson noted that the Water Department is doing general maintenance, hydrant cleaning and snow removal at the Town Hall.

Councilman Powers made the motion and Councilman Puleo seconded the motion to add to the Agenda and approve Patricia Jakubowski attending the 2005 Spectrum Conference, May 11th,2005 in Syracuse at an approximate cost of \$300. Ayes-5. Noes-0. Carried.

Councilman Cirocco made the motion and Councilwoman Glownia seconded the motion to approve the Board of SupervisorG¦+s Resolution as follows:

the leadership, organization, or procedures to meet new demands;

NEW, THEREFOR, BE IT RESOLVED that the AssociationG+s Inter-Community Committee

explore methods in which the County of ErieG¦+s current structure of government can be dissolved and re-establish a Board of Supervisors and report back with their findings to the Association of Erie County Governments within sixty (60) days; and be it further

RESOLVED, that the Association of Erie County Governments actively explore what it will

take to re-establish a Board of Supervisors to govern the County of Eire; and be it further

RESOLVED, that the President of the Association of Erie County Governments forward

a copy

of this resolution to all elected local, County, State and Federal officials who represent residents within Erie County.

Councilman Powers being the delegate for the Town of Elma at the Association of Towns in New York City informed the public of 19 resolutions presented with 17 passed at this meeting. Resolutions pertained to Medicaid reform, highway aid, wicks & prevailing wage reform, health insurance, disability benefits, charge-backs, (HAVA) help America vote verification and centralized equipment, maintenance of roads, volunteer fire & emergency reform, arbitration, tort reform, collateral source legislation, exemption reform, condo assessments, police accident report fees, ATV use, speed limits and pension reform.

Councilman Puleo made the motion and Councilman Powers seconded the motion to approve and proceed with the following letter:

Due to the Erie County fiscal crisis, the Town of Elma is willing to step forward for the people of our Community. Located in the center of our Town is Elma Meadows Park and Public Golf Course. It is vital to our Town that the Park and Course remain open. The closing will have an economic impact as well as a great loss to our families for recreational use. Elma Meadows has been a great asses to the Town as well as the County.

Therefore, the Town of Elma Boards finds it unacceptable for Elma Meadows to remain closed indefinitely and wish to enter into discussions with the County for the Town of Elma to take ownership of the park and the Golf Course. It is our obligation as Town and County Government to work as diligently as possible to open the Park.
