After Roll Call, the Clerk read the Notice of Public Hearing for Appeals Case # 1195 for Walter Przybyl, Jr., 2541 Bowen Road, Elma, who is requesting a variance for the setback requirement of 50 feet to be reduced approximately 10 feet. §144-97 C-4. Walter Przybyl Jr. was present to discuss his case. Chairman Harrington mentioned that the board was given a drawing with an approximate figure and wanted to know if there is an exact figure on what the setback would be. Don Trzepacz asked Mr. Przybyl if the measurement was taken from the center of the road. Mr. Przybyl did not have the exact measurement and was unsure of where the measurement was taken from.
