Water Superintendent Eugene Stevenson advised that no further action needs to be taken at this time against Triton Valley Mobile Home Park, plans should be submitted by September. Conrady Consultant Services has completed the inspection of the three (3) water tanks advising that they will not need any repair and do not need to be re inspected for five (5) more years. The tanks are in good condition. Fire hydrants are being painted and water services are being installed. Mr. Stevenson would also like to put out to bid a 2014 pick up truck replacing the 2002 F250.

Councilman Nolan made the motion and Councilman Malczewski seconded the motion to put out to bid a 2014 pick up truck for the Water Department returnable by August 21st at 3:00PM and will be opened at the Work Session at 6:00PM. Ayes-5. Noes-0. Carried.

Speaking for Highway Superintendent Wayne Clark Supervisor Powers noted that Schultz Road will be paved and the County has replaced a culvert on Girdle Road to alleviate the road flooding.

Town Attorney Phyllis Todoro noted that NYSEG's proposed cell tower on Stolle Road was tabled at the Planning Board for further requirements.

Councilman Nolan made the motion and Councilman Petrocy seconded the motion to approve the following resolution WHEREAS, The Town of Elma, recognizes that plowing and de-icing town, as well as county roads, is in the best interest and safety of its residents, and WHEREAS, Erie County and the 25 towns within the county have negotiated contracts which assure that the majority of the county roads within the towns would be maintained according to the same snow and ice control methods used on all town, roads, and WHEREAS, such methods have been approved by the Erie County Department of Public Works, and WHEREAS, in the past, all costs of manpower, equipment, and materials have been calculated to the satisfaction of all parties, and WHEREAS, any issues that have arisen during snow and ice control in previous years have been resolved by all parties involved, and WHEREAS, a new contract between the Towns and Erie County is currently being negotiated, and WHEREAS, on March 20, 2013, there was a tentative agreement between the towns and Erie County which included a 3 year term with an annual increase of 5.0% as was past practice, and WHEREAS, this agreement was considered fair and within the budgeting confines of Erie County, and WHEREAS, on April 16, 2013, Erie County made a counter proposal to increase the contract from 3 years to 5 years and to reduce the monetary increase to 0.5%, and WHEREAS, the county proposed rate is one the towns cannot afford, and WHEREAS, the budgetary planning for 2014 is going to be starting in many municipalities, and WHEREAS, the deadline for towns to order road salt de-icier is now past. NOW THEREFORE BE IT RESOLVED, that the Town Clerk of the Town of Elma is to transmit copies of this resolution to Erie County Executive Mark Poloncarz, Erie County Legislator Joseph Lorigo, Erie County Chairwoman Betty Jean Grant, and Erie County Department of Public Works Commissioner John Loffredo, and the other towns within Erie County.
