# PUBLIC HEARING - 7:00 PM NYSE&G COMMUNICATIONS TOWER, STOLLE RD, ELMA

## **MINUTES OF PUBLIC HEARING- July 16, 2013**

Prior to the Public Hearing, as required by Elma Town Code, NYSEG mailed a notice, certified/return receipt, of intent to build a communication tower, to all residents within five hundred feet of the proposed site. The receipts were returned to the Building Department and a copy of the list of the property owners was provided to the EPB. All owners were verified as having received a notice.

The EPB was also given notice by the ZBA that at their June 11th meeting, NYSEG was granted a continuance of their request for a variance on height requirements.

The Public Hearing was opened at 7:00 PM by Deputy Chairman Millard. Representing NYSEG were Attorney Josh Silver and Engineer Peter Stritzinger. Attorney Silver reviewed the tower information as presented in earlier meetings:

- Will be 300' high and located on 32 AC on Stolle Road, Elma.
- Substation with high voltage transmission line.
- Will support a microwave antennae.
- Will be a link between Elma and Lockport.
- Will support smart grid technology.
- NYSEG is subject to Department of Defense requiring latest technology.
- Public utilities need to upgrade equipment & support smart grid initiatives.

Mr. Stritzinger said this will provide day to day communications for utility personnel including emergency supplemental information. Computerized devices will monitor electricity and report back to a secondary collector to a prime collector in Binghamton.

Then NYSEG can identify now what has been damaged whereas before they had to send out crews.

He said that: "This is the most critical site in WNY and that it is going to take information from many different sites; also monitor from substation to substation; and includes renewable resources." Attorney Silver said that NYSEG needs the tower to be 300' to maintain a line of sight. It will be 99.9% reliable.

Ten people attended the Public Hearing, eight of them residents living in the 500' radius zone. Addresses were: 221, 371,381, 391 and 431 Stolle Road. Concerns expressed with responses from NYSEG:

- Affects on wildlife now and long term: None.
- Any affects on water table: No affect surface water. No drainage district.
- Increased traffic: Only NYSEG personnel. Tower is unmanned.
- Health affects: None according to multiple studies.
- Affects on property values: Unknown.
- Length of construction: 6-8 weeks to build.

In response to questions from the EPB, Mr. Stritzinger said there are similar towers in Binghamton, Lockport and Orchard Park. He explained the basic construction, stating that the tower could withstand severe ice buildup and winds of 110 mph. He also said that the tower is 140' from the access road but put on the other side, it would be 30' from wetlands. Attorney Silver said that the tower could support expandability which could be mutually beneficial. He also said that the smart grid technology is efficient and should result in considerable savings.

Deputy Chairman Millard concluded the Public Hearing by asking how many were in favor of the tower? No responses. How many were opposed to the tower? All. The Public Hearing was adjourned at 8:15.

- 1. Submit an official copy of the survey of the entire parcel.
- 2. Consider locations for tower: north? east? distance from residents for each.

- 3. Copy indicating Wetlands delineation.
- 4. Tower lighting detail including wattage.
- 5. Any health study information on short/long term affects.
