Chairman Malczewski said flag lots benefit the Town by allowing everything to get built without adding new infrastructure. Erie County has adopted policies regarding prevention of urban sprawl and not adding new roads. Mr. Malczewski also reviewed the latest request for historical preservation - the creation of historical districts vs. identification of individual homes. He said that the Town Board is not in favor of historical districts.

Chairman Malczewski suggested that the MDCC request permission of the Town Board to continue for another six months even though, the current moratorium is for one year with six month extensions allowed by the Town Board. (The MDCC has met for six months inclusive of the July meeting.)
