Thomas Reid had developed a series of detailed questions as outlined under Agenda Item II. A. - E. These were distributed to the Members via email for their review prior to the MDCC Meeting. Chairman Malczewski deferred to Thomas Reid and Michael Cirocco in assisting in the discussion of these items. The two reports from Drew Reilly were also reviewed by the MDCC.

Page -2- MDCC (12/18/13)

Mr. Reid and Mr. Cirocco posed a number of potential scenarios that could occur as a result of our current building code. Members were asked to respond as to whether each would be acceptable in terms of preserving the rural character of Elma. Also looked at were the proposed definitions from Drew Reilly, some suggested as replacements and other as additions to the existing code.

The MDCC ultimately agreed that the best way to protect the Town of Elma was to make the definition of Multiple Dwellings as simple as possible – thus eliminating any ambiguity and the future potential for new types of units not currently identified – as being acceptable because they were not specifically named in the definition. They also decided that the MDCC was not going to deal with duplexes or in-law apartments at this time. Deleted were auxiliary housing units. Townhouses, condominiums and apartment buildings which would fall under the definition of Multiple Dwellings.

Proposed Definition of Multiple Dwelling:

Three or more dwelling units on a parcel or plot regardless of ownership or leasehold.
