

ELMA WELL REPRESENTED AT EMPACT AMERICA CONFERENCE

Representatives from around the nation and the world attended a two day conference in Niagara Falls to better understand the catastrophic effects an electromagnetic pulse could cause for our nation, and its communities.

The conference stemmed from the concern of Henry Schwartz, CEO, Steuben Foods in Elma. It's objective was to inform local Government officials and citizens of a better understanding of the threat and how to protect our infrastructures. Electromagnetic pulse (EMP) occurs when a solar flare or a high altitude nuclear weapon is exploded at high altitude above the United States and interacts with the earth's atmosphere, ionosphere, and magnetic field to produce an EMP radiating down to the earth.

Weapons designed and deployed with the intent to produce EMP have a high likelihood of damaging electrical power systems, electronics, and information systems upon which our American society depends.

The primary avenues for catastrophic damage to the nation are through our electric power infrastructure and telecommunications, energy, and other

infrastructures. These in turn, can seriously impact other important aspects of our nation's life, including the financial system; means of getting food, water and medical care to the citizenry; trade; production of goods and services. The recovery of any one of the key national infrastructures is dependent on the recovery of others. The longer the outage the more problematic and uncertain the recovery will be.

Elma Town Supervisor, Michael Nolan, and Elma's Disaster Coordinator, Edward Sauer, addressed the protection of the Town of Elma's infrastructure if such an event might occur.

As you enter the park each child will be given an orange ticket for a pumpkin and a ticket for a chance to win a bicycle. One bike will be awarded to a boy and one to a girl. Adults will be given a ticket for a chance on the theme basket and afghan raffles. Hot dogs will be provided by the Elma Fire Department,

and chili will be provided by the Jamison Road Fire Department and popcorn, courtesy of Elma Hardware.

Elma residents are encouraged to enter the pie contest which is open to adults and children. The applications for the pie contest are due no later than October 1st, and may be found on page four of this issue. Applications will also be at the Town Hall. In addition, children, K-3 and special needs, will have the opportunity to enter a coloring contest through the primary schools. Pictures will be picked up from the schools on October 1st.
